Do not ignore these papers. If you do ignore these papers, the court may enter a default judgment against you. This means that the other party can legally garnish your wages or take your property.

1. FIRST DECIDE IF YOU WISH TO CONTEST THE CLAIM:

You should answer on the form provided for your answer, even if you feel you are the wrong defendant.

Your answer should contain every "defense" you have.

If you decide to contest this claim in the Justice of the Peace, Ward J you must contact the Justice of the Peace Ward J in writing within ten (10) days, including weekends, of receiving this citation. If you do not a default judgement may be entered against you.

, DECIDE IF YOU WISH TO HIRE AN ATTORNEY TO REPRESENT YOU:

You can represent yourself and if the other party decides to have an attorney, you will be given an opportunity to secure an attorney if you desire to do so.

a. POSSIBLE DEFENSES INCLUDE:

- I. No jurisdiction or improper "venue" this has multiple factors involved and if you need assistance you should contact an Attorney.
- II. Contributory negligence (negligence on part of the plaintiff)
- III. Discharge in bankruptcy
- IV. Error or mistake.
- V. Previous compromises or payment of an obligation.
- VI. Excessive damage claimed.
- b. If you have a claim of your own against the party suing you, you may file a reconventional demand. The plaintiff must be served with this "reconventional demand" prior to the trials. The defendant (plaintiff in reconvention) must pay a basic filing fee of \$50.00.
 - I. You will have the opportunity at trial to present your witnesses and evidence, and the opportunity to pose questions to your opponent(s). You may be asked to answer your opponent's questions. The procedure will be slightly less formal than an ordinary trial, with the judge asking questions to understand the case and ascertain that truth.
 - II. After all the evidence and testimony have been taken, the judge will announce the decision regarding which party has won the case and any award of relief.

 There are times when the judge will not render a decision immediately after the trial

There are times when the judge will not render a decision immediately after the trial but will take the matter "under advisement" to conduct research. You will be notified of each decision.

III. If you and your attorney do not agree with the decision made by the judge, you will have fifteen (15) days from the signing of the judgement, or from receipt of the judgement, if the case has been taken under advisement, to appeal your case.
